FINANCIAL ASSISTANCE



Vectra Customer Service and Billing understands how important Vectra test results are to you and your health care provider. You both need this information at the time of your appointment to ensure that you are making the best decisions about your course of treatment.

Our goal is to ensure that cost is not a barrier for anyone with Rheumatoid Arthritis (RA) who needs a Vectra test. Your out-of-pocket cost depends on your health care plan. Vectra Financial Assistance CARE Team will work with your insurance provider to help you get the appropriate coverage. Payment plans and financial assistance are available to you through the CARE program.

What you need to know about Vectra coverage

- The Medicare program fully covers Vectra twice a year¹
- Private insurance plans vary from fully covering the Vectra test to requiring copays of various levels
- If you cannot afford your copay, you can apply for assistance with the CARE program
- If you are uninsured, you may apply for assistance through the CARE program
- If out-of-pocket cost is estimated to be more than \$90, Vectra Customer Service will call you before running the test

What you need to know if you have out-of-pocket concerns

If you cannot afford your copay, deductibles or other out-of-pocket costs related to the test you may be eligible for assistance through CARE. If you encounter financial hardship associated with your bill, **Vectra will work directly with you toward your complete satisfaction.**

Ways Vectra Financial Assistance Program can help:

- CARE Financial Assistance plan reduction-income levels under \$103,000**
- 0% Interest (10-month) payment plans

CARE Patient Assistance, example based on a household of four:†

Less than \$51,500	\$0
\$51,501 - \$77,250	\$45
\$77,251 - \$103,000	\$90
